 - a. All vehicles (Except Hino Mini Bus) can be inspected at the COMSATS University Islamabad Campus.
 - b. Inspection of the Hino Bus can be made at the CUI, Attock Campus at the address: COMSATS University, Kamra Road, Attock.
2. Earnest Money of **Rs. 20,000/-** for each vehicle in shape of Pay Order/CDR in favor of COMSATS University Islamabad shall have to be attached by the prospective bidders for participation in the bidding, which will be refunded after bid opening to unsuccessful bidders. Bids with earnest money below Rs.20,000 (for each vehicle) will be rejected.
3. The highest bidder will have to deposit **25%** of the bid price in cash at the spot. In case the highest bidder fails to deposit this amount on the spot, his Earnest Money will be forfeited.
